For all applicants: Change Point of Diversion on Inside Domestic Use Water as per the Village Ordinance; Section 9-2-9: The landowner shall assign the domestic right to use water to the Village as per the Change Point of Diversion Agreement with the Village of Bosque Farms. **If domestic right to use water cannot be diverted, the landowner will be required to purchase the necessary water rights. The State Engineer's decision on your request for diversion of water rights will not be made immediately.** \_\_\_\_\_ (Init.) The landowner may elect to have the Village of Bosque Farms purchase water rights for said individual at a rate established by the Village of Bosque Farms. The rate will be based upon user needs and requirements at a minimum charge of \$800.00.

**We the undersigned understand we must install, at our cost, the water line from the meter to our residence. We must install a shut off valve on their service line as close to the meter as possible. We also understand that the Village water system is for DOMESTIC USE ONLY. All irrigation or outside water use must be provided by a private well.** \_\_\_\_\_ (Init.)
