## VILLAGE OF BOSQUE FARMS APRIL CLEANUP

The **Bosque Farms Fall Cleanup** will be held on Saturday and Sunday, the following two weekends in April:

**Sat. & Sun. April 17 & 18**  
**Sat. & Sun. April 24 & 25**  
**From 8AM to 4PM**



The dumpsters will be located at the **new Maintenance Yard next to the Waste Water Treatment Plant on DeSmet Road.**

***Due to a limited number of dumpsters, residents will be allowed ONE load per household.***

**Residents must bring a water bill or utility bill for proof of residency.**

**NO** computers, televisions, tires, concrete, large appliances (refrigerators, washers, etc.), ammunition or explosives, batteries, toxic chemicals, paint, asbestos or pesticides will be accepted.

**Small appliances** such as toasters and microwaves are accepted. For more information, call the Village Office at 869-2358.

# PLANNING & ZONING

Ordinances are reminders of what we can do to maintain the excellent quality of life we have here in the Village. The following are examples of what can happen when Ordinances are not followed:

1. When household trash is allowed to accumulate in the yard, or animals are not cleaned up after, disease carrying insects are attracted and the yard becomes unsightly to look at and unpleasant to live near.



2. General debris is stacked on a property; it detracts from the beauty of our Village and gives wild animals, like skunks, a place to hide.

3. Inoperable vehicles left in a yard leak oil and other fluids and leach battery acid, which taint the groundwater and soil we use to water and grow our vegetable gardens.

4. An overgrowth of weeds is a fire hazard and harbor mosquitoes.

5. A resident builds a structure without a permit. These structures may not be covered by a homeowner's insurance policy.



6. A resident operates a business without a Home Occupation Permit and the business may compromise the character and safety of the neighborhood.

The Property Maintenance Ordinance is a reminder of what we can do to maintain an excellent quality of life in the Village. I hope that we can all work together responsibly to provide a safe, healthy, community today and in the future. Please take the time to review a copy of the Property Maintenance Ordinance either at the Village Office or on line at [www.bosquefarms.us](http://www.bosquefarms.us) so you, as a resident, can be informed.

The Federal Emergency Management Agency (FEMA) has completed a review of Valencia County and has identified approximately 95% of the Village as located within the "100-year" Floodplain. ("100-year" means there is a 1% chance of flood in any given year.) FEMA has updated the Flood Insurance Rate Maps (FIRMs) accordingly. The new FIRM's will go into effect on August 19, 2010. The Village joined the NFIP (National Flood Insurance Program) in 1987 and adopted a Flood Hazard Prevention Ordinance as outlined by FEMA and the NFIP at that time. The Ordinance was updated in 2000 when the FIRM was updated. Our Ordinance will again be updated when the FIRM goes into affect. The NFIP insures buildings, including mobile/manufactured homes, with two types of coverage: structural and content. Structural coverage is for the walls, floors, insulation, furnace and other items permanently attached to the structure.

Contents coverage may be purchased separately provided the contents are in an insurable building. The mandatory purchase requirement applies to all forms of federal or federally related financial assistance for buildings located in the Special Flood Hazard Area (SFHA). While not mandated by law, a lender may require a flood insurance policy in any zone on a Flood Insurance Rate Map.

The NFIP offers flood insurance to those areas that FEMA has identified as flood hazard areas and that participate in the NFIP. All development within the floodplain must be regulated. Development is generally defined by FEMA as "any man-made change to the floodplain. This definition is all encompassing. Elevating a residential structure above the Base Flood Elevation (BFE) can decrease the cost of flood insurance. Building a residential structure below the BFE will greatly increase flood insurance rates. Non-residential structures located in SFHA (100-year floodplain) must be elevated to at least one (1) foot above the BFE or the structure must be flood-proofed. Additions that meet the standards of substantial improvement, which also involve significant improvements and/or structural changes to the existing structure, require the existing structure and the addition be elevated to the BFE. You may review Chapter 11-1 Flood Hazard Prevention Ordinance on the Village's website at [www.bosquefarms.us](http://www.bosquefarms.us) and the proposed FIRM's are available for review in the Planning & Zoning Office. The new FIRM's will go into effect on August 19, 2010.

## Reminders:

Weeds will be appearing before you know it ~ they need to be removed from yards, easements, and don't forget the private irrigation ditches.

All building improvements, metal fences, and any building development must start with a development review by the Planning & Zoning Officer. If in doubt about any type of buildings, structure or fence on your property – please contact me to avoid being in violation.

Inoperable vehicles are still a major concern within the Village, as they are not allowable in the Village. If you have concerns about your antique, historic, special interest, parts cars or inoperable motor vehicle – please contact me.

## WATER DEPARTMENT

Once again spring is almost upon us. The Utility Department would appreciate the clearing of weeds and debris from around your water meter, grinder pumping unit and control box.

**REMINDER:** Grinder pumps do not like grease!!! Please place grease in the garbage, not down your sinks. Grease and oil damage grinder pump motors and do not mix well at the Waste Water Treatment Plant. You could be held liable for damages caused by grease build up in your grinder pump.

Also, grinder pumps don't appreciate powdered laundry soap. It creates a residue on the pump motors.

## WATER CONSERVATION IN YOUR LAWN AND GARDEN

*Let it grow.* Adjust the height of your lawnmower to cut your grass higher. This helps protect roots from heat stress and reduces the loss of moisture to evaporation.

*Stay true to your roots.* Promote deep root growth with proper watering, aerating, fertilization, grass-clipping control and attention to lawn height. A lawn with deep roots requires less water and is more resistant to drought and disease.

*Plug away.* Aerate clay soils at least once a year to help the soil absorb and retain moisture, which helps your plants.

*Make the beds.* Add a 2 to 3 inch layer of mulch around flowers, shrubs and trees to help the soil retain moisture, discourage the growth of weeds and provide essential nutrients.



*Soak don't spray.* Install drip-irrigation or soaker hoses for more efficient watering in planting beds and beneath shrubs and trees.

*No cannonballs!* If you have a pool, keep the water level low to minimize loss from splashing. Use a cover to slow evaporation. An average-sized pool can lose about 1,000 gallons of water per month if left uncovered.

*Make it shine.* Use a bucket of soapy water and a hose with a shutoff nozzle to wash your car. Better yet, wash your car at a commercial car wash that recycles water.

*Think small.* When choosing plants, keep in mind that younger, smaller ones require less water to become established.

*Conserve water naturally.* Select plants that are native to your region and can thrive with little or no extra

watering. Your local nursery can help you identify and select drought-tolerant plants.

*Keep it cool.* Water your lawn and landscape plants early in the morning when the sun's rays aren't working to evaporate your water.

At least 30 percent of water used annually by a single-family suburban household is for outdoor irrigation. A large portion of that goes to waste through evaporation or runoff caused by over-watering.

**Free Burn Permits are available in the Village Office.** Always call before you burn and ask if it is a "burn day" which is a day with winds not over 15 MPH. Lets keep our Village clean and free of weeds and blowing leaves but do it safely and by Bosque Farms rules.



# I AM YOUR ANIMAL CONTROL OFFICER

I am your *Animal Control Officer*. I am not the dreaded “Dog Catcher” or the “Murderer” you call me.

I’m not the one who allows your pet to roam the streets, to contract diseases from other free roaming animals, to be hit by passing motorists or poisoned by rotting garbage. I am the one who must look into those sick, pain-glazed eyes, try to remove the animal without causing it further pain and then humanely “put it to sleep” to end its suffering.



I’m not the one who allows your pet to breed, then dumps the unwanted puppies and kittens on roadsides and in shelters. I’m the one who must find the tiny animals before they die of starvation, exposure or disease and as an act of mercy, exterminate them.

It hurts me to be forced to kill hundreds of animals each year but because of your irresponsibility, I have no choice.

I’m not the one who abandons unwanted animals on farm roads, telling myself some friendly farmer will surely take them in and give them a good home. But I am the one who picks up the frightened animal who waits in vain for its beloved master, wondering why it has been abandoned. I am the one who must help that friendly farmer trap, tranquilize or kill that animal because it has begun to roam in packs with other abandoned hungry animals, killing livestock, fowl and game.

I am not the one who breeds and fights dogs in the name of “sport.” But I’m the one who fights the breeders and participants, and pick up dead and dying animals left behind.

I’m not the one who keeps a pet confined in an area too small-without food, water, shelter, or exercise. But I must deal with the irresponsible owner who does.

I’m not the one who refuses to spend time and money to keep up regular inoculations that all pets require. But I am the one who must pick up the sick animal that is dying of preventable disease.

So remember, the next time your child is bitten by a stray dog, your trash is dumped and scattered, your pet is lost, stolen, poisoned or hit by a car, it is the Animal Control Officer you call, not the “dog catcher.”

The next time your pet is picked up, or you are cited for neglecting or abusing it, remember that I am only trying to get you to fulfill your responsibility to your pet, your neighbor and yourself.

**Do not scorn me. Respect me, for I am the product of your irresponsibility. I love animals, and I do care.**

To mail a 1-ounce letter, it will continue to be \$0.44 until further notice by the U S Post Office. You may use the Forever Stamps, regardless of when purchased, to mail 1-ounce letters even after a price change, without the need for additional postage. Forever Stamps are widely available through Post Offices, commercial retail outlets such as grocery stores and on line.



Military postage is \$11.95 in a Flat Rate Box. Three sizes of these boxes are available in the Post Office and are mailable anywhere in the US.

## FIRE DEPARTMENT NEWS

Spring 2010 is upon us already and it seems that winter will never end. With the moisture that we received this winter the fire season hopefully will be uneventful.

Our March training meeting was spent on the river levy making sure all of our wild land fire fighting equipment was in good working order. As usual 20 members attended and the training was great review.

On March the 6<sup>th</sup> we traveled to the NM Fire Fighters Training Academy in Socorro. There were 14 of us that participated in four live burns in the academy's



fire buildings. It was a great refresher covering such topics as: tactics, communications, incident command, search and rescue, team work, thermal imagers, with an emphasis on fire fighter safety. We

all came home tired and smelling like smoke.

The paperwork is in process for our new breathing air system. This includes a new compressor and fill station that will allow us to fill our own air bottles. Currently we get our breathing air from a private company out of Albuquerque. Twelve new air packs are included with extra bottles. These items will enhance our capabilities by providing our fire personnel with the newest technology as well as extended on air minutes.

It's that time of year again when we need to check our smoke detector batteries. Remember to replace your smoke detector if they are 10 years and older.

Remember to get a burn permit and call in to see if it is a burn day.
