Lillie McNabb, Bosque Farms resident, stated that the Older America group recently handed out 120 food boxes at the Los Lunas Transportation Center. She thanked Bob and Mary Courtney and Virgil Proctor for being excellent Village residents who between the three of them, they got an elderly resident's swamp cooler going recently.

Daniel Romero, Bosque Farms resident, complained about AC Disposal Services restrictions on containers for horse manure. He also complained about prairie dogs on his property.

Lee Wharton, Bosque Farms resident, asked if the Governing Body was going to address the issue with residents not receiving the AC Disposal letters. She also complained about the fireworks on July 4. E. Consideration of the Community Center Rental Agreement

Councilor Walkup stated that he was not ready to approve the rental agreement because too many changes have been made recently to the original amended agreement.

Councilor Chavez asked for direction from the Governing Body.

It was decided that the council would look at the rental agreement and submit their suggestions/changes to Gayle.

Councilor Wallace moved to approve Resolution #797-13 authorizing the Village of Bosque Farms to pick up seventy-five percent (75%) of the PERA Municipal General Member Coverage Plan 2 Member contributions. Councilor Walkup seconded. **Motion carried unanimously.**

H. Consideration of Resolution #798-13 Authorizing the Village of Bosque Farms to Pick Up Seventy-Five Percent (75%) of the PERA Municipal Police Member Coverage Plan 3 Member Contributions
