#### 1. CALL TO ORDER

He stated that the first quote from Spectrum was dated June 2, 2021 and was for \$44,575.00; the second quote from Spectrum was dated for July 7, 2021 and was for \$52,900.00. The other quote was from Flo Trend and was \$43,400.00. There was discussion on the two quotes. Utilities Director Chavez recommended the box from Spectrum because of the construction.

Mayor Pro Tem Kennedy made a motion to purchase the sludge box from Spectrum in the amount of \$52,900.00 plus freight. Councilor Burks seconded the motion. Mayor Pro Tem Kennedy amended the motion to include aby applicable sales tax. Councilor Burks amended his second. **Motion carried unanimously.** 

# 5. CONSIDERATION OF PUBLICATION OF AMENDMENTS TO 10-1 COMPREHENSIVE ZONING ORDINANCE

Planning and Zoning Officer Mike Montoya explained the proposed amendments to the 10-1 Comprehensive Zoning Ordinance. There was discussion on the amendments.
