12. <u>Council to Review and Take Action on RFP for Engineering On Call Services.</u>

Clerk Administrator Michael Limon explained that the committee appointed by Council had concluded that Molzen & Corbin outscored Anchor engineering by a significant margin. (The score sheets were presented to Council) Clerk Limon stated the committee's recommendation would be to award Molzen & Corbin the On Call Services agreement however would suggest Anchor engineering to apply again in the future as the

Clerk Administrator would like to have two engineers on contract in the future as this is normal practice in most municipalities.

Councilor Baughman questioned the Clerk Administrator as to why the Council couldn't suggest the Village take both bids and hire both firms. Clerk Administrator Limon stated that due to the current copy paste health of the budget for the past 4 years he can confirm the Village has enough workload and finances to afford one engineer on call however cannot recommend two. Also, Clerk Limon went further to explain that the RFP stated that only one engineer would be awarded at the conclusion of this process.

Martin J. Garcia requested to read a statement into the minutes of this meeting that would summarize his dissatisfaction with the scoring matrix the panel used to come to the result of Molzen and Corbin. Mr. Garcia went further to state his dissatisfaction that the current administration's unwillingness to appoint two on-call engineers at once.

Councilor Cheromiah stated that the Governing Body requested that the Clerk come up with a process to score and gain an engineer on call for the Village of Bosque Farms. Although Council and members of the public maybe in disagreement with outcome of the scoring the process was still followed as Clerk Limon was instructed to do. Councilor Cheromiah suggested that the Village move forward with this item.

Councilor Baughman stated that he would like to hire a second engineering firm in the future.
