#### 12. INFRASTRUCTURE CAPITAL IMPROVEMENT PLAN PUBLIC HEARING

Discussion on Infrastructure Capital Improvement Plan FY 2022-2026. Mayor Walkup gave an overview on what is already on the plan. Clerk Jones gave an update on projects that are currently on the plan. Mayor Walkup asked for suggestions on the plan. Council Burks suggests WW Treatment Clarifier and Sludge Processing remain ranked at number one, Road Construction ranked at number two, VRECC-700 MHZ System ranked at number three and the remainder of the projects stay in current order after number three. Discussion on Fire and Police Station Renovation remaining ranked at number one, Road Construction ranked number two, Fire and Police Station Renovation ranked number three, VRECC-700 MHZ System ranked number four and the rest of the projects stay in current order after rank four. There were no additions to the plan.

#### 13. <u>NEW BUSINESS</u>

#### A. Consideration of Extension of Contract with AC Disposal for Solid Waste

Discussion on concerns about AC not currently offering recycling. Village Attorney Jarmie advised the Governing Body that as long as both parties are acting in good faith, then there is no need to make a provision to the contract. Council Burks moved to extend the contract with AC Disposal Services for the last four-year extension with the finding attached that the recycling program is not feasible due to facilities and availability not being in the region and that it will be revisited in six months to see the status of the facilities.
