3. Pledge of Allegiance

Mayor Gilliespie led those in attendance in the pledge of allegiance.

4. Executive Session

Village of Bosque Farms Village Council met in executive session to discuss the appointment of the interim clerk administrator and the hiring of a water/wastewater operator pursuant to 10-15-(2) NMSA.

Councilor Baughman moved to enter executive session and Councilor Wood seconded.

At 6:10pm, Councilor Baughman moved to return to regular session and Councilor Wood seconded. Attorney Jarmie certified that only the specified matters were discussed during executive session, and no action was taken.

6. Presentation

Mayor Gillespie recognized and thanked Police Chief Andrew Owen for his years of service to the Village.

7. Public Comment

Resident Ashley Reser commented on the lack of EMS services. She stated that she has concerns about the Village going forward with Vernon Abeita.

Resident Justin Reser stated that in 2016, after ten years, he left EMS because of Vernon Abeita. He stated that he turned in an EMS application but has not heard back.

Resident Stef Scanland stated that she called to have an issue on the agenda, but it was denied. She stated that the Fair Board tried to silence our Senator and this is a breach of public trust.

Resident April Hall asked about the street lights on Highway 47, and stated that she's been asking for 3 years. She pays the highest property tax she has ever paid and asks where it's going.

Resident Shoshanna Avrishon stated that she wants EMS squared away. She stated that a neighbor falls and the fire department helps lift him. She gave thank you cards to the fire department, police department and animal control, and one to Councilor DeSmet.

Resident Damon Torres stated that another resident had a medical event. Torres, a volunteer firefighter, has his EMS basic, but was limited in what he could do. He stated that AMR is often at stat zero, and waiting puts residents at risk when minutes matter.

Resident Lily McNabb stated that it's good that the Village is starting to care. The Bosque Farms Fair was the best ever. She thanked all the volunteers and stated that the police department is awesome.

Gene Garcia, water/wastewater applicant, stated that his background check shows a domestic violence from 14 years ago. Mr. Garcia stated that he was trying to protect his daughter from a convicted sex offender, her step-grandfather, and that three years later the court ruled in his favor. He stated that he has had no police contact since 2011 and he would hate for this to disqualify him as a job candidate.

8. <u>Departmental Reports</u>

Police Chief Owen recited his police report and statistics for his department and animal control.

Fire Chief Schneider presented a year-end report on behalf of the fire department.

Interim Clerk Lopez shared updates from the Clerk's office.

9. Mayor & Council Reports

Councilor Baughman commented on weeds on the sidewalks. He wants to ask NMDOT about weeds in the retention pond areas and raised areas on sidewalks. He also wants to ask Prodigy about Scada systems communicating with boosters to meet demands.

Councilor Wood stated that people came for the fair and helped, and it was nice.

Councilor DeSmet reported on the Los Lunas Blvd groundbreaking, and stated that the Booster Pumps are doing good and the dangerous Chlorine gas is out.

Mayor stated that there is a tremendous amount of negativity and partial truths on Facebook, causing issues and damaging the Village's cohesion.

Treasurer Maes stated that she did not have a Treasurer's report this month due to the volume of IPRA requests preventing the Deputy Clerk from doing her other daily duties, such as bank reconciliation. The Treasurer reported the GRTs for the month, which had decreased by ten thousand dollars from the prior month.
