Chief Owen presented the Police Department report for October 2023. Animal Control now falls under the Police Department.

Councilor Baughman nothing to report. He stated he will leave his driveway open when they trench Cole Road so fire, police and medical can get through. If residents on Green Drive need to get through, he will let them know personally.

Councilor Cheromiah nothing to report.

Councilor Burks reported the new brush truck is supposed to be in as of January. ISO rating inspection will be in late November, early December. Results will be sometime in January. ISO rating is a 3 which is high. We are shooting for a 2 which will further bring down insurance rates within the village. All five Boy Scouts of America units in the county are still actively recruiting. They meet on Monday nights at the Peralta Methodist Church and they meet on Thursday nights at the Church of the Nazarene. He stated he talked with Mike Padilla, who brought attention to the ditch across Cottonwood Drive, and they are working on doing an engineering solution at Governor Abeita's request. They are working on ensuring a solution to avoid conflict.

Mayor Pro Tem Wood reported Isaiah Abeita is working for the library through Workforce Solutions. The library has various classes including Tai Chi, dance, adult reading, and reading to dogs. They are going to have a talent show and they are also doing a reading challenge. They put on a carnival, as well as a genealogy workshop. The library sale will be November 25, 2023. They have passes for 15 historical sites that you can borrow for three weeks at a time. It has historical sites around the State of New Mexico that you can get admitted into for free.

Mayor Walkup reported voting is November 7, 2023. Early voting is currently at Valencia County Clerk's office. Early voting will be held at the library starting Saturday, October 21, 2023 until November 4, 2023 from 10:00 AM to 6:00 PM.
