## COUNCIL OF THE VILLAGE OF BOSQUE FARMS, NM MINUTES OF THE REGULAR MEETING SEPTEMBER 18, 2025

### 1. CALL TO ORDER & ROLL CALL

Mayor Gillespie called the meeting to order at 6:00 p.m.

Present were Mayor Chris Gillespie, Mayor Pro Tem Ronita Wood, Councilor Erica De Smet, Councilor Michael Cheromiah, Councilor Tim Baughman, Rapporteur, Ginger Eldrige, Police Chief Andrew Owen, and Attorney Mark Jarmie.

#### 2. PLEDGE OF ALLEGIANCE

Councilor De Smet led the Pledge of Allegiance.

## 3. EXECUTIVE SESSION PURSUANT TO 10-15-1H (2) NMSA, 1978, PURSUANT TO PERSONNEL MATTERS, TO HIRE A POLICE OFFICER

Councilor Baughman made a motion to adjourn to executive session at 6:01 p.m. Mayor Pro Tem Wood seconded the motion. **Motion carried unanimously.** 

Councilor De Smet made a motion to reconvene at 6:12 p.m. Councilor Baughman seconded the motion. **Motion carried unanimously.** 

Roll call as follows: Mayor Pro Tem Wood, for; Councilor De Smet, for; Councilor Cheromiah, for and Councilor Baughman, for. **Motion carried unanimously.** 

Attorney Mark Jarmie stated that discussion during the executive session was limited to 10-15-1H (2) regarding personnel matters and nothing further was discussed.

#### 5. PRESENTTION: COPS AND RODDERS

Chief Owen gave presentation for Cops and Rodders. It is the fourth annual car show. The money raised goes toward the Special Olympics of New Mexico, specifically our Valencia County Cobras. It will be held on September 27, 2025, from 10:00 am to 2:00 pm.

### 6. PUBLIC COMMENT FOR NON-AGENDA ITEMS

Suzanne Heske, resident of thirty (30) years, noted governing body minutes have not been updated since April 2024 and P&Z has not been updated since January of 2024. She wants them updated on the website.

Dolly Wallace, resident since 1952, thanked Village for getting the mosquito problem addressed although a bit late. She is sad to hear we have lost another administrator.

Stef Scanland, resident, asked why it took so long to remove access to sensitive information from former employees.

CJ Kettle, resident, urged council to adopt the proposal put forth by Valencia County Fire Department. He also had questions and concerns regarding the proposal.

Mike Brogdon, resident since 1980, also brought up concerns about council minutes and finance not being posted. It needs to be addressed immediately. He is concerned about hidden agendas.

#### 7. DEPARTMENTAL REPORTS

Police Chief Owen presented August 2025 police and animal control reports.

Fire Chief Brogden thanked the Kellers for putting on the car show at the fair. Thirty-five hundred dollars (\$3,500.00) was donated to the fire dept. Supplies that were damaged from the Rio Grande Fire were replaced. The Fire Department is asking for more communication from the administrative and mayor offices.

#### 8. MAYOR & COUNCILOR'S REPORTS

Councilor Baughman no report.

Councilor Cheromiah no report.

Councilor De Smet is hosting a Meet and Greet for the five (5) candidates for the two (2) open council positions. It will be at Cowboy Hall on September 25, at 6:00 pm. There will be a Q&A session. She brought it to the council's attention that there is no treasurers report for the second time in a row.

## 10. <u>VALENCIA COUNTY PROPOSAL TO PROVIDE EMERGENCY MEDICAL</u> <u>SERVICES FOR THE VILLAGE OF BOSQUE FARMS</u>

Chief Propp gave a presentation on a proposal to provide emergency medical services for the Village of Bosque Farms. Benefits would include: Valencia County Fire Department will provide response twelve (12) hours a day, seven (7) days a week based on peak call volume. Bosque Farms will remain the fiscal agent for all capital assets. In the event the Village ambulance is out of service, Valencia County will place a spare unit in service to eliminate down time. There was discussion. Chief Brogdon spoke on behalf of BFFD and state they champion this proposal.

## 11. COUNCIL TO REVIEW AND TAKE ACTION ON VRECC JPA

Tommy Sanchez, District Director for VRECC 911 center for Valencia County and Isleta, gave a presentation on the Amendment to Joint Powers Agreement between City of Belen, Village of Los Lunas, Village of Bosque Farms, the City of Rio Communities and Valencia County, New Mexico.

The resident, nor representative of resident, requesting the variance was present at the meeting. Attorney Jarmie advised it was appropriate to have discussion without representative of person requesting variance.
